Dear *Colleague,*

As you are aware, the KAYAKALP Scheme- a national initiative for promotion of 'Swachhta' in public health facilities to promote cleanliness, hygiene and infection control practices was launched on 15th May 2015. Presently under the Scheme, facilities in the rural areas upto Primary Health Centres(PHC) level including District Hospital(DH) and Community Health Centre(CHC) are being covered.

Starting this year, it has been decided that the **Kayakalp Scheme** will be extended to the **Urban Areas** also in all the States/ UTs. To facilitate the extension of Kayakalp Scheme to urban facilities, a set of points, checklists to be used, award amount etc., is enclosed at Annexure -I.

You are requested to initiate necessary action regarding implementation of Kayakalp guidelines in urban areas such as conducting trainings, assessments etc. For further clarification/ technical assistance regarding roll out of the Scheme in urban area, States/ UTs may contact Dr. J. Extension of Kayakalp Guidelines in Urban Areas

Annexure- I

The key points for extension of Kayakalp guidelines in urban areas are as follows:-

- i. Kayakalp awards given to the health facilities in urban areas would depend on number of available functional U-PHCs/U-CHCs. Categorization can be in two groups:-
 1. U-CHCs
 2. U-PHCs with beds and U-PHCs without beds
- ii. Facilities in metro cities would form a separate sub- group for giving Kayakalp awards. Each metro in turn can be divided into zones/ regions/ districts. If there are adequate number of U-PHCs in a zone or region, winner U-PHC can be declared at zonal / division level.
- iii. If the number of U-PHCs are not adequate, the states/ municipalities may club such U-PHCs to create a cluster of at least 20 facilities for assessment purpose. Cluster formation/ identification of U-PHCs would be done at the level of States/ metros themselves.
- iv. If in a state/UT, there are less than 10 UPHCs in total; even then also it is eligible to receive Commendation awards.
- v. UPHCs under PPP mode may be included under Kayakalp scheme as per state requirement.
- vi. All facilities getting 70% or more score on External assessment would be eligible for Commendation award.
- vii. The tools in the existing Kayakalp guidelines to be utilized for evaluation as follows :
 - a) For U-CHCs - Refer Section- A (DH, SDH & CHC)
 - b) For U-PHCs (with beds) - Refer Section- B (PHC with Beds)
 - c) For U-PHCs (without beds)- Refer Section- C (PHC without Beds)

viii. The Award criteria for the urban facilities are as follows:
