I. <u>INTRODUCTION</u>

The Ministry of Health and Family Welfare has rolled out 'Operational Guidelines for improving quality Assurance in Public Healthcare Facilities', which suggests institutional framework for Quality Assurance in States, districts and Facilities. This system requires assessment of health facilities internally by the facilities and the district teams followed by the State and National level.

National Health Systems Resource Centre (NHSRC) has taken the task to create a pool of Quality assessors for which a five-and-a-half-day external assessor training was organized from **04**th **April to 09**th **April 2022**. The Training Module was designed with a view to enable the trainees for the assessment of the healthcare facilities against the pre-defined checklists contained in the Assessor guidebooks.

This report therefore provides information about how the five- and half--day workshop was conducted, lessons learnt and the way forward for improving the quality in public health facilities in India.

The training was participatory in nature. A set of Operational guidelines for improving Quality in Public Healthcare Facilities, Assessors Guidebook for Quality Assurance in DH, CHC, PHC, UPHC, HWC-SC, LaQshya and MusQan was shared with the participants. The sessions were divided into five days and followed by post training evaluation on next day, consisted of elaborate sessions describing Standards, Measurable Elements, Check points and all Areas of Concern as mentioned in the Operational Guidelines. Participants were divided in 11 groups and a Field visit was conducted in 2 DHs and 03 UPHCs in the State of Delhi. Training also consisted of many exercises, which led to healthy brainstorming of the participants.

Feedback of training sessions and accommodation at hotel was taken from the participants and the report contains feedback analysis and suggestions given by the participants.

A written evaluation was undertaken at the end of the training as per the schedule, the participants who have scored minimum 70 % and above will be empaneled as external assessor.

There were total **55 participants**, who were qualified MBBS Government and Non- Government participants.

II. AIMS AND OBJECTIVES OF TRAINING

The aim of the five- and a half--day training was to strengthen the knowledge, skills and assessment capacities on Operational Guidelines for Improving Quality in Public Healthcare Facilities 2021. The specific objectives are as follows:

- To create a pool of qualified Assessors for undertaking National & State Assessments for NQAS, LaQshya and MusQan Certification etc.
- To acquire knowledge & skills to conduct objective assessment of healthcare facilities against pre-defined norms.
- To equip participants with knowledge of key concepts, tools and methodologies of quality improvement.

III. PREPARATION: -

The QPS division of NHSRC prepared the course curriculum. The training was divided into five- and a half--day and consisted of elaborate sessions describing Standards, Measurable Elements, checkpoints and all Areas of Concern as mentioned in the Operational Guidelines. A field visit was also organized in 2 DHs and 3 UPHCs in





Delhi (11 groups) which gave the participants a platform to conduct assessments. In addition to this, all the participants were given many exercises, thereby making the training more participatory.

V. Pre-Training Evaluation


At the onset of External Assessor Training the pre-evaluation examination has been conducted for all the participants, consisting of 20 multiple choice questions. All 55 participants have been appeared in the examination.





VI.Inaugural and Welcome Address

The External Assessor Training started by Welcome address which was delivered by Dr J N Srivastava, Advisor, QPS, NHSRC.



Dr. J N Srivastava Advisor Quality and Patient Safety Division, along with QPS team, NHSRC extended a warm welcome to all the participants from various organizations. He briefed the participants on the National Quality Assurance Programme and its importance for public health facilities. He conveyed that this five- and a half--day training would be an enriching experience for all. After that, all the participants introduced themselves and shared what they understood of the term quality and what are their expectations out of this training. Technical sessions started after inaugural session of the training.

VII. PRESENTATION BRIEFINGS

DAY 1-04th April' 2022

Session 1: - Quality in Public Health System: An overview

The First Session of the Day 1 was on the "Quality in Public Health System in India".

The session was delivered by Dr. J N Srivastava. He started with the requirement expected with the participants in the training as well as the appeal process in the system to make the training successful.

Dr. Srivastava told about the Public Health System in India way back from Bhore Committee recommendations. He further discussed the growth of Health sector in India after Alma Ata declaration and National Health Policy.





Then he told the participants about Primary Care in nineties and how government is managing burden of health status currently. He further explained National Health Mission, its structure, 5 key strategies and implications.


Dr. Srivastava laid emphasis about the high mortality due to low quality of health system and the need to improve the health system through the implementation of NQAS standards. He explained the historic perspective of accreditation process. He also explained that NQAS is based on the Donabedian Model of QoC and are designed for DH, CHC, PHC, UPHC, H&WC (SC) AEFI Surveillance LaQshya and MusQan to improve the health care services. While giving an overview of NQAS he talked about the journey of Quality Assurance in National Health Mission

Dr. JN Srivastava also briefed the participants about the ISQua Accreditation of the NQAS. He explained the participants about the possible role as trained NQAS assessors. Kayakalp initiative under Swachh Bharat Abhiyan, LaQshya for Maternal & Newborn Care, Mera Aspataal & Patient Safety were discussed in brief. IT solution for management of certification process and Quality process through GUNAK App was also one of the talking points.



<u>Session 2:- An Introduction to National Quality Assurance Standards including intent of the Area of concerns</u>

The second session was taken by Dr. Deepika Sharma on Introduction to National Quality Assurance Standards. She gave an overview of the National Quality Assurance Standards, how they are arranged, scope of different area of concern, intent of various standards and how the standards are arranged in various level of Health Care Facilities. She briefed the participants about the books to use as a guide for reference. She talked about the anatomy of the checklist by explaining about the Area of Concern, Standards, Measurable elements and checkpoints in the departmental checklists. She gave the comparative overview of the standards which are applicable at different level of Health Care Facilities.



Session 3: Measurement System under National Quality Assurance Standards

Dr. Sushant Agarwal took the third session on Quality Measurement System & Assessment Protocols. The learning objectives of his session was to understand the architecture- the layout & design of different components of NQAS, comprehend & appreciate: area of concern, standards, measurable elements and checkpoints, identify & understand different methods of assessment, complete clarity/ understanding of scoring rules and get acquainted with assessment protocol.

He talked about the characteristics of the NQAS Programme and explained how it is an implicit tool. He made the participants understand the anatomy of the checklist & explained about the area of concern, standard and measurable element, checkpoints and scorecard. While deliberating he talked about the relationship between these various components.

The four types of assessment method were discussed in detail with the participants, which included

- Observation
- Staff interview
- Record Review
- Patient interview

Dr. Sushant talked about the compliance as well as scoring rules. He gave an overview of the eighteen checklists and at last discussed the key features of these standards.







Session 4: - Brief and Objectives of the exercise

Dr. Deepika Sharma gave brief introduction and importance for conducting exercises against the sessions con- ducted regarding Intent of Area of Concern & Measurement system.







Session 5: - Exercise & discussion with moderator: Intent of Area of Concern & Measurement system

After the brief discussion on the intent of Area of concern & Measurement system; exercise was monitored by 6 nos. of moderators. For this activity 6 groups were formed and the participants were asked to give answers on the basis of discussion with respective participants in group and moderator. Slides were shown to the participants one by one and they were asked to give the scores as 0, 1 & 2 as per the NQAS measurement system.



DAY 2-05th April' 2022

The 2nd day training started with recap of the last day sessions by Dr. Deepika Sharma.

Session 1: - Service Provision under NOAS Framework

The first session of Day 2 was taken by Dr. Chinmayee Swain. She explained how to assess the facility as per the six standards under area of concern A and gave a comparative overview of the Service provision in different types of Health Care facilities. She explained about checking the availability of services mentioned below:-





- Curative Services
- RMNCH+A
- Diagnostics
- National Health Programs
- Support Services
- Services as per local needs



Session 2: - Patients' Rights under NQAS Framework

The second session of Day 2 was taken by Dr Sushant Agrawal. He talked about the definition of patient Rights and discussed the various fundamental patient rights. He talked about the seven rights of the patient in context of: -

- Availability of Drugs, Diagnostics, Doctors and Devices.
- Accessibility in terms of physical access, financial access, information and non-discrimination
- Acceptability in terms of privacy, cleanliness, gender equity and courteous behavior.
- Quality in terms of clinical protocols, clinical records, infection control and outcome of care.





Dr. Sushant Agrawal explained the assessment of patient rights in public health facilities while dealing the standards of Area of concern B narrated below: -

- **B1** Information
- **B2** Accessibility
- **B3** Privacy and Confidentiality
- **B4** Participation
- **B5** Free Services
- **B6** Ethical Management







Session 3: Inputs under NQAS Framework

The third session of Day 2 was taken up by Dr. Shivali Sisodia. She covered all the seven standards pertaining to this area of concern C

- C1 Infrastructure and Space
- C2 Physical Safety
- C3 Fire Safety
- C4 Human Resource
- C5 Drugs and Consumables
- C6 Instrument and Equipment
- C7 Staff Competence







Session 4: Support Services under NQAS Framework

Ms Vinny Arora took over this session and started the presentation by explaining why support services are important under NQAS framework. She explained that support services are the backbone of hospital operations which are usually most neglected area in public hospitals. She laid emphasis on how support services directly and indirectly lead to poor quality of services for example poor upkeep of facility, long down time of equipment and little efforts in process improvement may give high & visible results to clinical care.

She gave the brief description of all the standards under support services and gave glance of comparison of standards as per level of facility. She made the participants understand the importance of the standards and means of verification were also explained in details for support services by giving examples.







Session 5:- Clinical Services under NQAS (General Clinical Services)

Dr. Arpita Agarwal took over this session and talked about the general clinical services in which she discussed standards E1 to E9.

- Registration, consultation & admission
- Clinical assessment & reassessment
- Continuity of care and referral
- Nursing care
- High risk & vulnerable
- STGs & generic drugs
- Safe drug administration
- Maintaining, updating, storage of records
- Discharge of patient.








Session 6: - Exercise & discussion with moderator: Area of Concern(A,B,C & D)

After the brief discussion on the intent of Area of concern & Measurement system; exercise was supported and guided by the 6 nos. Of moderators. For this activity 6 groups were formed and the participants were asked to give answers on the basis of discussion with respective participants in group and moderator. Slides were shown to the participants one by one. All the groups were given scores for their responses.



DAY 3-06th April' 2022

The 3rd day training started with recap of the last day sessions by Dr. Neeraj Gautam.

Session 1: - Area of Concern G (G1-G7)

Dr. Deepika Sharma took this session. Through this session she explained about the quality management in a facility and how a facility can improve their process and achieve the quality improvement. How to identify the problems and using quality tools how can the quality teams achieve the target of providing the quality services to the population near the health care facility.

Presentation made it clear how employee satisfaction and patient satisfaction can play important role in quality improvement of a facility. Having Quality checks in the laboratory can improve the quality of diagnosis, having written and implemented procedures, records & formats, work instructions can give the wide spectrum to the employees to improve their knowledge and skills. Using the quality tools to identify and solve the problems,





conducting various audits with their analysis, preparing a strategic plan to achieve the mission and vision of the facility.



Session 2: -Outcome Indicator Including excercise

To make outcome indicator clearer and more understandable, Dr. Sushant Agrawal took some exercise on quality management system and outcomes.

He gave the exercise on patient satisfaction, prescription audit, external quality assurance score for lab tests, PICK chart, pareto analysis, histogram, run chart & Failure Mode and Effects Analysis (FMEA).







Session 3:-Clinical services under NQAS (Specific & RMNCHA clinical services)

The session was delivered by Dr. J N Srivastava. He talked about the general clinical services in which he discussed standards E10 – E 16. He elaborates on the following points: -

Standard E10 The facility has defined and established procedures for intensive care.

Standard E11 The facility has defined and established procedures for Emergency Services and Disaster Management.

Standard E12 The facility has defined and established procedures of diagnostic services.

Standard E13 The facility has defined and established procedures for Blood Bank/Storage Management and Transfusion.


Standard E14 The facility has established procedures for Anesthetic Services.

Standard E15 The facility has defined and established procedures of Operation theatre services.

Standard E16 The facility has defined and established procedures for End-of-life care and death

He gave a comparative view of the standards applicable at different level of health care facilities.

Continuing with Standard E17 to E22, he focused on Maternal and Child Health Services including Intranatal care, Antenatal Care and Postnatal Care. He also emphasized on established procedures for care of new born, infant and child, and procedures for abortion and family planning including Adolescent Reproductive and Sexual health Services.



Session 4:- Assessment of National Health Programs under NQAS

Dr. Kanika Jain took this session. Through this session she explained about the quality components of the NHP. She explained the programs by explaining them under communicable and non-communicable diseases and IDSP/IHIIP.

Under communicable disease she covered the following programs:

- National Tuberculosis eradication Program (NTEP)
- National AIDS Control Program
- National Vector Borne Disease Control Programme
- National Leprosy Eradication Programme

Under non-communicable disease she covered the following programs:

- National Programme for Prevention and Control of Cancer, Diabetes, Cardiovascular Disease and Stroke
- National Tobacco Control Programme
- National Mental Health Programme
- National Programme for Control of Blindness





- National Programme for Prevention and Control of Deafness
- National Programme for the Health Care of Elderly
- National Oral Health Care Programme

She gave the brief description about the IDSP/ IHIIP programs. He explained about the difference between old and new IDSP portal.







Session 3: - NOAS Assessment for Infection Prevention

Dr. Chinmayee Swain explained the infection control practices. She made the session interactive by asking questions related to various infection control practices and by demonstrating various practices like hand hygiene.

She made the understanding of the standards very convenient by explaining the hand hygiene practices, personal protective equipment, equipment processing, environment control and biomedical waste management. She also explained about how these standards are distributed in different checklists and things to be kept in mind while conducting assessment of the standards. She also gave an overview of the standards at various levels of facility. Her session was pictorial which made it more interactive and convenient for the participants.








<u>Session 4 : Exercise on Area of Concern (E)- Primary Care Services & Secondary Care Services & Discussion</u>

The group exercises were monitored by six moderators where all the participants were given the sheet. Various slides were shown and the participants were asked to identify the standards.



Session 6: IT initiative under NQAS platform

This session was taken up by Mr. Anand Yadav. He oriented the participants about the downloading and usage of the app, which can be used during an assessment by the participants.







DAY 4-07th April' 2022

The 4th day training started with recap of the last day sessions by Dr. Annapoorna K.N.

Session 1: - Area of Concern G (G8-G10)

Dr. Deepika Sharma took this session. Through this session she explained the risk management (Existing and potential risks) in the health care facilities, how to assess, report, evaluate and manage the risks as per risk management plan and also talks about the clinical governance framework to improve the quality and safety of clinical care processes in the facilities



Session 2:- NOAS Assessment of Family Planning

Dr. Divya Valecha and Dr. Pragati took the session on Family Planning. Dr. Divya explained the National Family Planning Program (NFPP) through her slide. She explained the program by giving an overview by key objectives, policy level and service level. She briefly explained the areas of concern for the said program. The points of discussion were the contraceptive basket of choice under NFPP, modality of family planning service delivery, family planning services available in public health facilities, how media campaigns have played a pivotal role in usage of contraceptives, community-based schemes, Mission Parivar Vikas, IUCD & Sterilization services and schemes and compensation under sterilization scheme.





Dr. Pragati explained in detail about the Fixed day Sterilization services, storage and inventory management of FP commodities, eligibility criteria for sterilization clients, importance of informed choice and consent, documenting denial of sterilization and certificate of sterilization.

Dr. Pragati also explained about the Long-Acting Reversible Contraceptives (IUCD, Injectable MPA) and Short-Term Methods (COC, Centchroman and Condoms). She explained about the formation of State Family Planning Indemnity Subcommittee (SISC) and District Family Planning Indemnity Subcommittee (DISC). To understand the implementation of the Family Planning Program the importance of outcome indicators was also explained to the participants.








<u>Session 3: - Overview of MusQan Initiative and Assessing Critical Elements for the Quality Certification</u>

Dr. Sumita Ghosh gave an overview of the Child Health Services in India. Major areas covered under this session was MusQan. She started with the Strategic interventions under Child Health Program and assessing critical elements for the quality certification.



Session 4:- Principles of NOAS Assessment

NQAS assessment session was taken by Ms. Vinny Arora. She started with explaining difference between Certification & Accreditation and Assessment & Audit. She explained about the types of assessments and gave an overview of external assessment process with man days. She particularly explained the principles of assessment:- Integrity, Fair presentation, Due professional care, Confidentiality, Independence, Evidence based approach and Risk based thinking.



Session 5:- Conduct of Physical & Virtual Assessment

Mr. Gulam Rafey explained the process of external assessment in 3 phases which included pre assessment phase, assessment phase and post assessment phase. He also explained about the outcome of the certification process and the criteria for certification for all the types of facilities in detail respective to physical and virtual assessment.







Session 6:- NQAS Assessment challenges & it's solutions

Dr. Alisha Dub took the session to give an overview of challenges faced by assessor during pre-assessment and post assessment phase. She also gave an overview of some do's and don'ts while performing an assessment along with discussion on the documents, records and policies that need to be submitted by the state for certification. She lead the discussion by giving examples.



Session 7: Key components of Report writing

Dr Sushant Agarwal took this session and discuss issues related with the report writing, ideal way of making NQAS/LAQSHYA assessment report, common mistakes during report writing and basic principle for report writing.







Session 8: Briefing about the field visit & Group work

Dr. Abhay Kumar briefed the participants about the field visit and gave them the instructions to be followed during the field visit. He briefed the participants about the DH and UPHCs selected for the field visit and divided the participants into groups. Each group had team coordinator from NHSRC team who were responsible for the coordination and guiding the teams. Separate vehicles were arranged for the field visit and the details were shared with the participants. Dr. Abhay Kumar also emphasized on the rules to be followed during the field visit & group work.




