Under the National Quality Assurance Programme, baseline and periodic assessments of health facilities are required to be undertaken by the facilities and state teams. Such assessors need to have a thorough understanding of intent of the quality standards and proficiency in the assessment protocols.

After the conduction of baseline assessment, facility's key personnel also undergo 3-days trainings to understand the critical actions for the Gap closure, application of quality tools, analysis of patient satisfaction, measuring key performance indicators, etc. This module is of 03-days duration.

States are advised to plan for State level ToTs to conduct these two training. Further such trainers would conduct 02-days Internal Assessors Training and 03-days Quality Improvement Training as per the need of the Districts and Health Facilities. Following personnel may be considered for State level ToTs:-

1. NQAS Internal Assessor ToT

- a. Empanelled NQAS External Assessors
- b. Quality Professionals trained at TISS, Mumbai
- c. Faculty of Medical Colleges, SIHFW, SHSRCs and other institutions of repute.
- d. Public Health Professionals having at least 10 years of experience
- e. Incharge of large public hospitals
- f. Incharge of NQAS nationally certified facilities

2. Quality Improvement Trainings

- a. Empanelled NQAS External Assessors
- b. Specialists working in Public Health Facilities, which are NQAS certified
- c. Nursing Professionals with 10 years of experience
- d. Hospital Managers of NQAS certified facilities with 10 years of experience

State Quality Nodal Officers may develop annual training calendar, so that all trainings are evenly spread-out round the year. Training calendars may please be shared with NHSRC (QI Division). Please issue suitable instructions to all concerned.
