'Safe care' is fundamental to ensuring the quality of health services. There is clear consensus that care should be effective, safe, timely and people-centered to unearth the holistic benefits of quality health services. Quality health care comprises of safe surgical care and safe childbirth. It is also about injection safety, blood safety, medication safety, medical device safety, safe organ, tissue and cell donation. Additionally, it covers aspects related to appropriate biomedical waste management, prevention of Healthcare Associated Infections (HAI) and more.

Every year, in low- and middle-income countries (LMICs) nearly 13.4 crore adverse events occur due to unsafe care, resulting in 26 lakh deaths. Such occurrence of adverse events is one of the ten leading causes of deaths and disabilities in the world. Estimates show that in developed countries as many as one in 10 patients is harmed while receiving hospital care. The harm can be caused by a range of errors or adverse events. Of every 100 hospitalised patients at any given time, seven in developed and 10 in developing countries will acquire HAIs.

In India, in the absence of a suitable learning and reporting system, the exact extent of healthcare associated harm remains unknown. Dr Ashish Jha through a study published in BMJ estimated that approximately 52 lakh injuries occurred annually due to medication errors in India.<sup>4</sup>

#### **World Patient Safety Day**

The Seventy Second World Health Assembly (WHA), vide its resolution WHA 72.6 on 28 May 2019 urged member countries to keep patient safety as a key strategic priority in the Universal Health Coverage (UHC) agenda. The resolution further requests all member countries to develop normative guidance on minimum standards, policies, best practices and tools for patient safety, including safety culture, human factors, hygiene infrastructure, clinical governance and risk management. Since then, 17 September is observed as World Patient Safety Day (WPSD) every year.

The overall objectives of WPSD are to enhance understanding of patient safety, increase public engagement in health care safety, and promote action to prevent and reduce avoidable harm in health care. Each year a theme is selected to focus on a priority area, critical to patient safety and UHC.

In view of the COVID-19 pandemic, the theme of WPSD for the year 2020 was 'Health Worker Safety: A Priority for Patient Safety'. The National Health System Resource Centre (NHSRC) in collaboration with the International Society for Quality in Healthcare (ISQUua) organised a national webinar.

Shri Rajesh Bhushan, Secretary Health & Family Welfare, Ministry of Health & Family Welfare (MoHFW)delivered the inaugural address. Eminent national and international experts made presentations to an audience that comprised over 1200 participants.

The theme selected by WHO for World Patient Safety Day 2021 was 'Safe maternal and newborn care', highlighting the significant burden of risks and harm which women and newborns are exposed to, when receiving unsafe care during childbirth.

It is estimated that approximately 46% maternal deaths, over 40% stillbirths and 40% newborn deaths take place on the day of birth. Most of these deaths and stillbirths are avoidable through the provision of safe and quality care by skilled health care professionals, working in a supportive environment. In view of these facts, MoHFW launched the LaQshya initiative, which aims to improve intrapartum and immediate postpartum care in the Labour Room and Maternity Operation Theatre (OT). Since maternity care is also affected by issues of gender equity and violence, women's experiences during childbirth have the potential to either empower or inflict damage and emotional trauma on them. Therefore, this year, WHO has created a campaign slogan called, "Act now for safe and respectful childbirth!" calling upon all stakeholders to accelerate necessary actions for ensuring safe and respectful childbirth.

To reiterate the commitment of the MoHFW, Government of India (GoI) on the occasion of World Patient Safety Day, celebrated Rogi Surasha Saptaah from 11–17 September 2021. The States and Union Territories (UTs) were provided with a detailed day-wise action plan to commemorate the day and the states were encouraged to utilise it along with the liberty to add more activities, as required by them.

#### **Objectives**

The overall objectives of the World Patient Safety Day are to enhance global understanding of patient safety, increase public engagement in health care safety, and promote global action to prevent and reduce avoidable harm in health care. Following were the broad objectives set by the MoHFW for the Patient Safety Week:

1. Encourage health care professionals and key stakeholders of health systems to reinforce safe and quality mother and newborn care.

- 2. Raise awareness on issues of maternal and newborn safety, particularly during childbirth.
- 3. Sensitise all public health facilities, namely district hospitals (DH), sub-district hospitals (SDH), community health centres (CHC), urban community health centre (UCHC), primary health centres (PHC), urban primary health centres (UPHC) and health and wellness centres (HWC) regarding Rogi Suraksha Saptaah.
- 4. Address concerns of patient safety through a series of webinars on maternal safety, newborn safety, medication safety, radiation safety, ambulatory care, and fire safety.

#### **Activities**

To achieve the abovementioned objectives, various activities were carried out at the national as well as state level.

#### **National-Level Activities**

The National Health Systems Resource Centre (NHSRC) organised a series of webinars from 11–16 September 2021 on ensuring safe maternal care, newborn care, medication safety, safety in ambulatory care, radiation safety and fire safety. Eminent speakers were invited from the Mahatma Gandhi Institute of Medical Sciences (MGIMS), Wardha, the AllIndia Institute of Medical Sciences (AIIMS)Jodhpur, Peerless Hospital and B K Roy Research Centre, Kolkata, Atomic Energy Regulatory Board (AERB), and the Safdarjung Hospital, New Delhi. Nearly 200 participants joined these webinars daily. Webinars conducted during the Patient Safety Week are listed in Table 1.



Day 1: 11 September 2021, Maternal Safety

A webinar on 'Ensuring safe maternal care' was organised on Day1. The webinar was initiated with the welcome address by Dr J N Srivastava, Advisor, Quality Improvement Division at NHSRC. Setting the tone for the week-long activities, Dr Srivastava deliberated on the 'Importance of patient safety'. He emphasised how unintentional but avoidable harm to the patients takes place, while receiving care within the health facilities and domiciliary settings, especially through medication errors, HAIs, mishaps during procedures, post-surgery complications, patient fall, decubitus ulcers (bed sores), deep vein thrombosis and excess radiation exposure, etc. He addressed various blocks of 'Patient-centric' Quality of care (PoC) and explained initiatives such as NQAS, LaQshya, Kayakalp and National Patient safety framework to support patient safety.

In the discourse on 'Ensuring safe maternal care', Dr Poonam V. Shivkumar, Professor & Head of Department, Obstetrics & Gynaecology,the Mahatma Gandhi Institute of Medical Sciences (MGIMS), Wardha enumerated aspects related to 'Respectful maternity care and the universal rights of childbearing women'. The challenges in providing, and implementing safe maternal health and solutions were taken up for a broader discussion with the participants.

#### Webinar on ensuring maternal safety



On Day-1 a directive from the MoHFW was provided to the States that all facility staff must take the Surakhsha Sapath (Patient Safety Oath). They mustinvite eminent speakers locally or from other facilities with the aim of sensitising staff about the importance of patient safety. They must also make a plan for the next six days regarding patient safety

activities along with an effort to attend all national webinars from 11–17 September 2021.

#### Day 2: 12 September 2021, Newborn safety

A well-known expert in the field of Child and Neonatal Health, Dr. Arun K Singh, National Advisor for the Rashtriya Bal Swasthya Karyakram (RBSK) and Professor & Head of Department Neonatology, at the All India Institute for Medical Sciences (AIIMS), Jodhpur addressed the webinar on 'Ensuring safe newborn care.'He elaborated on how patient safety issues had an impact on newborn safety.

He began with emphasising on preconception care and how it is important in conceiving a healthy baby, and further explained critical periods which impact the cognitive trajectory and related interventions. The importance of the first 1000 days of the infant and human brain development, different nutritional needs of the infant and role of RBSKwas emphasised to ensure a healthy childhood.


On Day2, a directive from MoHFW was provided to the States to review the Maternal Surveillance Death and Response (MDSR) system in the facility for all maternal mortalities that occurred in the previous six months. It was provided to ensure learningbased actions to improve Quality of Care(QoC) prevent avoidable deaths. A review to ensure availability,

adequacy and usage of real-time partograph in the labour room was suggested along with an oath to use the partograph in all deliveries. Use of the 'WHO surgical safety checklists' was encouraged for all C-section surgeries during the day along with an oath to use them in all future surgeries.

#### Day 3: 13 September 2021, Medication SafetyWebinar on medication safety

Dr. Subhrojyoti Bhowmick, Clinical Director Quality & Research Department at the, Peerless Hospital, Kolkata was invited to enhance the knowledge of participants from across the country on 'Medication safety'. He started with classic examples of medication errors that caught media attention in India and how the topic is now a part of WHO's Flagship Global Patient Safety Challenges.

These factors led to medication errors as well as affected their cost bearers, yet these errors only signified faulty systems and not faulty professionals. The need for pharmacovigilance was discussed along with causality assessment including WHO-UMC Causality Assessment Scale and Naranio ADR Causality Scale. He concluded by suggesting strategies for preventing medication errors at the levels of the doctors, nurses, pharmacists and management and within that, revisiting the role of information technology (IT).



On Day3,a directive from MoHFW was provided to the States to orient all the mothers who were admitted and expecting on neonatal safety issues like personal hygiene, breastfeeding, nutrition etc. Also, to review usage of safe childbirth checklists in the facility and take an oath to use 'Safe childbirth checklist' in all deliveries.

#### Day 4: 14 September 2021, Safety in Ambulatory Care

Ms. Roopa Rawat, Project Manager, WHO Collaborating Centre for Emergency & Trauma Care at AIIMS, New Delhi spoke comprehensively on 'Ambulatory care' and the aspects that influence patient safety. She explained ambulatory care through the Swiss Cheez Model for understanding accidents and improving safety. The discussion touched the topics of International Patient Safety Goals (IPSG), Burden & Impact of Poor Ambulatory Basic Care (ABC), Strategy for Safe, Timely, Effective, Efficient (STEE) Care, and solutions like integration of processes, governance and information systems, standard documentation (digitalisation), capacity building,domiciliary setting like management of postsurgical complications, bedsores and medical reconciliation.

On Day4, a directive from MoHFW was provided to the States that every clinical department of the facility must identify 'Lookalike and sound alike medicines' and other 'High alert' drugs and take corrective and prevention actions to improve current practices.

#### Day 5: 15 September 2021, Radiation Safety

Ms. S. Mahalakshmi, from the Atomic Energy Regulatory Board (AERB) was invited to elaborate on 'Radiation safetyin health facilities' and shareher extensive knowledge on the topic. She talked about Ionizing radiation and the need to regulate radiation sources. She further explained the Regulatory Framework for ionizing radiation sources; safety requirements for medical applications; observations during inspections; ensuring patient protection in medical exposure; challenges and way forward.

On Day5, a directive from MoHFW was provided to the States to undertake prescription audits for randomly selected 30 prescriptions for irrational usage of drugs, diagnostics, legibility of handwriting etc. It was expected that they would take corrective and prevention action to improve prescription practices.

At State Level: It was expected to check AERB approval status for X-ray/CT/MRI machines. A review of availability, adequacy and usage of radiation safety equipment like

LEAD aprons, Gonad, thyroid and abdominal shields was to be undertaken. It was also expected to check TLD batches along with QC testing of X-ray machines. Taking corrective and prevention action to improve radiation safety of staff and patients was part of the effort.

#### Day 6:16 September 2021, Fire Safety

Dr. Aradhana Bhargava, Professor & Specialist Microbiologist, Vardhman Mahavir Medical College (VMMC)& Safdarjung Hospital, New Delhi was a guest speaker who elaborated on 'Fire safetyin the health facilities'. She first explained the fire triangle to participants and common causes of fire in the hospital and emphasised that 'once a burn patient always a patient.'

She then touched on the issues of recognition of fire hazards and risk in a health care facility, understanding fundamental aspects of fire safety, of potential fire hazards and

control measures, getting an overview of the fire protection system, and familiarising with overall administration of emergency management.

On Day6, a directive from MoHFW was provided to the States to check AERB approval status for X-ray/CT/MRI machines. A thorough review of availability, adequacy and usage of radiation safety equipment like LEAD aprons, Gonad, thyroid and abdominal shields was to be undertaken. It was also expected to check TLD batches along with QC testing of X-ray machines. Taking corrective and preventive actions to improve radiation safety of staff and patients was part of it.

#### Day 7:17September 2021, World Patient Safety Day

The final day of celebrations was divided into two sessions. All the States/UTs were invited to be part of the event that was held at MoHFW, Nirman Bhavan, New Delhi via virtual mode. The day started with theinaugural session and was followed by a technical session.

#### Inaugural session


The function was inaugurated by the Hon'ble Union Minister of Health & Family Welfare, Shri Mansukh Mandaviya. Shri Vikas Sheel, Additional Secretary and Mission Director, NHM, MoHFW welcomed dignitaries and participants and provided an overview of different initiatives taken by MoHFW for the promotion of quality and safe healthcare. Shri Rajesh Bhushan, Union Health Secretary MoHFWdrew attention to the different steps taken by the Government of India to ensure a safe healthcare system like the National Patient Safety Implementation Framework, National Quality Assurance Programme, Kayakalp and LaQshya.

The Guest of Honour Hon'ble Minister of State for MoHFW, Dr. Bharati Pravin Pawar spoke on the need to end all preventable antenatal deaths due to morbidities like anaemia, hypertension, sepsis, etc. Drawing from her own experience while practicing medicine, she observed that birthing a child in undignified settings can be a source of emotional trauma. The right of every woman to have a respectful childbirth was stressed upon. Noting the contribution of LaQshya scheme<sup>5</sup> in providing intrapartum and postpartum care, she stated that MusQan would similarly facilitate healthcare of infants and children below 12 years to the satisfaction of their parents. She quoted the Ramayana, 'Janani Janmabhumi Shcha Swarga Dapi Gariyasi' to emphasise the importance to be given to the institution of motherhood in Indian culture.

During the function, the Union Health Minister released the 'Operational Guidelines for Quality Assurance in Public Health Facilities 2021', Quality Darpan, a six-monthly update on key achievements and learnings under the NQAS initiative; the Ayushman Bharat Health & Wellness Centre e-booklet on quarterly progress report April-June 2021; Reference Manual for Integrated RMNCAH+N Counselling, MusQan, a scheme to target delivery of quality services to children in the health facilities; along with the Maternal Perinatal Child Death Surveillance Response (MPCDSR) software.

Shri Mandaviya felicitated the States and UTs for their performance in implementation of National Quality Assurance Standards (NQAS) and LaQshya during the function.

#### 1. Felicitation of States/ UTs for NQAS

**For CHCs:** Haryana, Andhra Pradesh and Tamil Nadu received the 1<sup>st</sup> prize, and J&K, Chhattisgarh and West Bengal 2<sup>nd</sup> prize in their respective categories.

*For DHs and SDHs:* 1<sup>st</sup> prize was awarded to Manipur, Andhra Pradesh, Telangana and Uttar Pradesh; 2<sup>nd</sup> prize to Jammu & Kashmir, Chhattisgarh, Gujarat and Tamil Nadu for different categories from I to IV.

**For PHCs**: Manipur, Haryana & Telangana received the  $1^{st}$  prize, while Tripura, Kerala & Madhya Pradesh got  $2^{nd}$  prize.

*For UPHCs*:  $1^{st}$  prize was won by Nagaland, Kerala and Gujarat, and  $2^{nd}$  prize was given to Mizoram, Haryana and Telangana.

#### 2. Felicitation of States/ UTs for LaQshya

For labour room in small States/UTs category, Chandigarh, Goa and Dadra Nagar Haveli & Damn & Diu received the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> prize. For labour room in larger states, Gujarat, Uttarakhand and Maharashtra received the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> prize. For Maternity OT LaQshya in small states category, certification awards were given to Chandigarh, Puducherry and Goa while those among large states were Gujarat, Madhya Pradesh and Maharashtra.

In his address Shri Mansukh Mandaviya said, "Quality is a journey and it is not a onetime activity, but one that should be integrated in our day-to-day practices. In other words, it should become a habit. Ensuring safety of patients is a continuation of ancient health

care practice. Sushruta's Charaka Samhita mentions many medical instruments which are used even today with minimal modifications. These showed dedication of our ancestors in preserving each and every life. All institution managers must make processes patient-centric and behaviour of health care workers towards patients an essential part of the treatment."

The function attracted a large audience with almost 3000 participants which included the abovementioned dignitaries along with Dr. Roderico Ofrin, WHO Country Representative to India, MoHFW officials, State Health Secretaries, Mission Directors NHM, Programme Officers from Quality, Maternal and Child Health, and other States including representatives from academic institutions, development partners, NGOs and international agencies etc.

#### **Technical Session**

After a week-long of enriching webinars and activities, the technical session marked the culmination of the Patient Safety Week. Maj. Gen (Prof) Atul Kotwal, SM, VSM, Executive Director NHSRC, and Dr. Roderico H Ofrin, WHO Representative to India opened the session with their welcome addresses, emphasising the need for action to reduce avoidable harm to patients.

#### Session: Key Priorities under Global Patient Safety Action Plan 2021-2030

Distinguished guest speaker Dr. Irina Papieva, Technical Officer Integrated Health Services, World Health Organization Headquarters elaborated on the 'Global Patient Safety Action Plan 2021—2030' which was submitted to the Seventy-Fourth World Health Assembly in 2021 through the 148<sup>th</sup> Session of the Executive Board in January and was then launched, after approval, in August 2021. She explained the seven strategic objectives:

- 1. Policies to eliminate avoidable harm in health care
- 2. High-reliability systems
- 3. Safety of clinical processes
- 4. Patient and family engagement
- 5. Health worker education, skills and safety
- 6. Information, research and risk management
- 7. Synergy, partnership and solidarity

The Action Plan lists governments, stakeholders, health care facilities and services, and the WHO Secretariat as partners in actions. While the framework for action is based on a 7x5 matrix, the Patient Safety Implementation Ecosystem is described to have five milestones for partners to follow.

#### **Session: Patient Safety in Maternal Health**

The impact of the National Flagship Programmes was taken up especially with regard to how successful they have been in bringing down the Maternal Mortality Ratio (MMR) in the country. Several tools were suggested for improving obstetric patient safety and unit performance for improving obstetric patient safety and unit performance. The session on 'Patient Safety in Maternal Health' conducted by Dr. Evita Fernandez included continuing education; simulation programmes; internal audits; best practice protocols; safety checklists; complete documentation; smart medical records; and maternity unit onsite consultations.

#### **Session: Patient safety in Newborn health**

Dr. Anita Shet, Senior Scientist, Johns Hopkins University started her views on the vision of John Hopkins Maternal and Child Health Centre, India.

Dr. Shet suggested moving towards safe newborn care in India by:

- Imagining newborn safety across the care continuum and different levels of service delivery from family to tertiary care centres
- Attention to sub-district and block level health facilities
- Introduction to and sustaining of maternal and child safety checklists
- Evaluating existing programmes like LaQshya for programme improvements
- Scaling up the midwifery initiative and incorporating a culture where protocols of patient safety in medical/nursing education training programmes were followed
- Making more investments in data analysis and learning from quality-of-care information across health facilities
- Paying special attention to respect, dignity and good communication to mothers and families more so during antenatal, intrapartum and post-partum care

#### Session: Pharmacovigilance Programme of India

Dr. YK Gupta, Ex HOD, Department of Pharmacology at AIIMS New Delhi and President AIIMS Bhopal & Jammu, was a speaker at the session on Pharmacovigilance Programme of India. He explained the rationale behind the Pharmacovigilance Programme of India initiated by GoI and how it is benefitting the population.



#### **Know Your Prescription (KYP) App**

Shri Tarun Gupta shared how the Know your Prescription (KYP) App works and aims to enhance patient compliance and adherence by improving therapeutic outcomes and patient satisfaction. It does so by explaining the doctor's prescription while addressing the patient's general queries in vernacular language.

On Day 7, a directive from MoHFW was provided to the States to take a pledge for promoting and observing *'Patient safety'*. This entailed checking availability, adequacy and usage of fire safety devices like fire extinguishers, fire alarms, sprinklers, check expiry date for fire extinguishers. A workshop was arranged in consultation with the fire department or agency on *'How to operate fire extinguishers'* for all staff. It was suggested to take corrective and preventive action to improve fire safety norms and also attend a National Webinar on World Patient Safety Day with the added advantage of joining the global campaign to light up the facility in orange colour.

#### State-Level Activities

After the directives from MoHFW, GoI, all State & UTs have actively participated and celebrated the *Rogi Suraksha Saptaah* across facilities. State Nodal Officers Quality Assurance were nominated to coordinate and disseminate information to all public

health facilities in the state. States issued directives to the districts with clear roles and responsibilities and list of activities to be done during the week-long campaign. Some states developed IEC related to Patient Safety considering the local context.

To join the Global Campaign, few states lightened up their iconic monuments, landmarks, local places and public health facilities in orange colour on 17 September 2021.

#### **Andhra Pradesh**

The Government of Andhra Pradesh celebrated a week-long *Rogi Suraksha Saptaah* (Patient Safety Week) from 11–17 September 2021 by implementing day-wise action plans starting from 11 September. Health care professionals from across the state joined a webinar on 17 September 2021 and took a *'Patient Safety Pledge'* on World Patient Safety Day organised by MoHFW, Delhi.

As part of medication safety, all OPD pharmacies, cold storage rooms and vaccine stores were

inspected by the team and checked for availability, adequacy, storage, vaccine safety and stock position of essential drugs etc. Maintenance of expiry dates of drugs, segregation of "look alike and sound alike" drugs, double checking of drugs and dosages of high alert medicines and high alert drugs charts were maintained in pharmacy stores and all wards.

As part of radiation safety activities, the team inspected the X-Ray and CT room. The TLD badge was not available in the Mahe DH and suitable action was taken to rectify

the same. Radiation safety norms were followed at RGGWCH and checked for the AERB approval status for X-ray machines. These were then reviewed for availability, adequacy, and usage of radiation safety equipment like LEAD aprons, Gonad, thyroid, and abdominal shields.

For fire safety, the availability and adequacy of the fire extinguisher was checked and updated. Demonstrations were given by the fire department regarding how to handle fire extinguishers when an emergency arrived. A hands-on training was also provided to the staff.
