INTRODUCTION

National Quality Assurance Program has been rolled out in all States/ UTs. NQAS is a systemic approach with well-established institutional framework from facility to national level. National Quality Standards are available for all level of health facilities from District Hospital to Sub-centre level. NQAS are accredited by the International Society for Quality in Healthcare (ISQua). Other programs like Kayakalp, LaQshya, SSS initiatives are an integral part of NQAS. There is an inbuilt system of Quality certification at state and national level of health facilities those exhibiting compliance to the NQAS norms and sustaining also.

For ensuring the child friendly services in public health facilities, Ministry of health and family welfare has launched "MusQan" on 17^{th} September 2021, for a pediatric age group of (0-12) years under the existing NQAS framework. Under this initiative 4 departments at DH level (Paeds OPD, Peads ward, SNCU and NRC), 3 departments (except NRC) at SDH level and 2 departments at CHC FRU level (except Pead Ward and NRC) will be assessed in public health facilities. To under the national level assessments for MusQan a 22^{nd} batch of external assessor's pediatrician training was organized by NHSRC on $22^{nd}-27^{th}$ August 2022. The workshop was held at NHSRC Theatre, First Floor, National Health Systems Resource Centre, New Delhi.

A five-and-a-half-day external assessor training was designed with a view to enable the trainees for assessment of the healthcare facilities against the pre-defined checklists contained in the Assessor guide-books. This report, therefore, provides the information about how the five and a half days workshop was conducted, lessons learnt and the way forward for improving the Quality in public health facilities in India. (Agenda attached as Annexure I).

A total of 49 participants attended the training (List is attached as Annexure II) out of which 36 were nominated by State Government and other 13 were non-Government participants. Training was participatory in nature. All the participants were divided in seven groups based on gender ratio, geographical areas, and organization capacities to maintain the equilibrium in the groups. (List is attached as Annexure III).

The sessions during the training were divided into five days and followed by post training evaluation on last day. Each day is divided in to two parts sessions followed by exercises. Sessions describes about all Areas of Concern, Standards, Measurable Elements, Check points and as mentioned in the Assessors Guidebooks of NQAS. Exercises in the training led to healthy brainstorming of the participants and made the concepts clear and understandable. At the end of each day, feedback is collected from the participants on the sessions conducted (List attached as Annexure -IV). Also, each group is scored based on their performance in the exercises on each day (List attached as Annexure -V). On fifth day all the participants were divided into twelve groups and all the participants visited three district hospitals of Delhi state. Lastly, on day 6th a written post evaluation exam was undertaken at the end of the training as per the schedule, the participants who have scored 70% and above marks are empaneled as external assessor. Total 50 participants appeared in post training evaluation exam (1 re-appeared). List of pass candidates is attached as Annexure - VI. Feedback of accommodation at hotel was also taken from the participants.

Overall feedback of the training is 4.47 out of the 5 (scoring on likert scale of 5).





AIMS AND OBJECTIVES OF TRAINING

The aim of the training was to strengthen the knowledge, skills and assessment capacities on of the participants to assesses the public health facilities under NQAS. The specific objectives are as follows:

- 1. To create a pool of pediatrician as Qualified assessors for undertaking national level Quality assessments under NQAS.
- 2. To equip participants with knowledge of key concepts of Quality, Quality tools and methodologies for Quality improvement.
- 3. To enhance the skills of participants to conduct objective assessment of healthcare facilities against predefined standards.

PREPARATION

The QPS division of NHSRC prepared the course curriculum. A field visit was also organized in three (03) District level health facilities in Delhi which gave the participants a platform to conduct assessments. In addition to this, all the participants were given many exercises, thereby making the training more participatory.

METHODOLOGY

A mix of methods were used for the 22nd NQAS External Assessors' Training Workshop. They are as follows-

- a) Power point presentations
- b) Brainstorming sessions
- c) Case studies
- d) Group work and Group Presentation
- e) Questions and Answers
- f) Practical Experiences from Field Visit

PRE-TRAINING EVALUATION

At the onset of NQAS External Assessors' Training, the pre-evaluation examination has been conducted for all the participants, consisting of 20 multiple choice questions.

All 49 participants have appeared in the examination.

INAUGURAL SESSION

The External Assessor Training started by Welcome address and introduction by Dr J N Srivastava, Advisor, QPS, NHSRC followed by welcome address by Guest of Honor, Maj Gen (Prof) Atul Kotwal, ED, NHSRC.

Maj Gen (Prof) Atul Kotwal, ED NHSRC briefed the participants on the National Quality Assurance Programme and its importance for public health facilities. He conveyed that these 5.5 days of training would be an enriching experience for all. After that, all the participants introduced themselves and shared what they understood of the term quality and what are their expectations out of this training. Technical sessions started after inaugural session of the training.







PRESENTATION BRIEFINGS

DAY 1- 22nd August' 2022

Session 1: - Quality in Public Health System: An overview

The First Session of the Day 1 was on the "Quality in Public Health System in India".

The session was delivered by Dr. J N Srivastava. He started with the requirement expected with the participants in the training as well as the appeal process in the system to make the training successful.



Dr. Srivastava told about the Public Health System in India way back from Bhore Committee recomme

tem in India way back from Bhore Committee recommendations and growth of health sector in India after Alma Ata declaration. Then he told the participants about primary health care way back in nineties. He further explained National Health Mission, its structure, 5 key pillars and their implications.

Dr. Srivastava laid emphasis about the high mortality due to low quality of health system and the need to improve the health system through the implementation of NQAS standards. He talked about the journey of Quality and explained the historic perspective of accreditation process. He also explained that NQAS is based on the Donabedian Model and Quality standards are available for DH, CHC, PHC, UPHC, H&WC (SC) to improve the Quality of Care at health facilities. NQAS have attained national (NHA& IRDA) and international accreditation (ISQua). He explained the participants about the possible role as trained NQAS assessors and touched upon the Kayakalp Initiative.

Session 2: - An Introduction to National Quality Assurance Standards

The second session was taken by Dr. Deepika Sharma on Introduction to National Quality Assurance Standards. She gave an overview of the National Quality Assurance Standards, how they are arranged, scope of different area of concern, intent of various standards and how the standards are arranged in various level of Health Care Facilities. She briefed the participants about the books to use as a guide for reference. She gave the comparative overview of the standards which are applicable at different level of Health Care Facilities.







Session 3: Measurement Systems under National Quality Assurance Standards

Ms. Vinny Arora took the third session on Quality Measurement System & assessment protocols. The learning objectives of his session was to understand the architecture, the layout & design of different components of NQAS, comprehend area of concern, standards, measurable elements and checkpoints, identify & understand different methods of assessment, complete clarity/ understanding of scoring rules and get acquainted with assessment protocol.



She talked about the characteristics of the NQAS

programme and explained how it is an implicit tool. She made the participants understand the anatomy of the checklist & explained about the area of concern, standard and measurable element, checkpoints and scorecard. She talked about the compliance as well as scoring rules. She gave an overview of the nineteen checklists at DH level.

Session 4: - Brief and Objectives of the exercise

Dr. Deepika Sharma gave brief introduction about the exercices, and guide the participants about the intent of conduct of the exercises regarding Area of Concern & Measurement system. Participants were diveded in six groups for the exercises.

Exercises were monitored by 7 moderators of the QPS division. For this activity, participants were asked to give answers in the Day 1 workbook on the basis of sessions conducted, the respective moderators supported their groups in the activity.







DAY 2-23rd August' 2022

The 2nd day training started with recap of the last day sessions by Dr. Chinmayee Swain.

Session 1 : - Area of concern A- Service Provision

The first session of Day 2 was taken by Dr. Deepika Sharma. She explained how to assess the facility as per the six standards under area of concern A and gave a comparative overview of the Service provision in different types of Health Care facilities. She explained about checking the availability of services as per the scope of facilities. She covered Standard A1 to A6 those comprises of Curative Services, RMNCH+A, Diagnostics, National Health Programs, Support Services and Services as per local needs. She breifed the participants that merely by saying services are available does not ensure the service availability, rather available services should be delivered to the end user to get compliance in this section.

Session 2 : - Area of concern B- Patients' Rights

The second session was taken by Dr Abhay Dahiya. He talked about the patient Rights and their responsibilities fundamental patient rights. He briefed about the six standards those encompass: -Availability of Drugs, Diagnostics, Doctors and Devices, Accessibility in terms of physical access, financial access, information and non-discrimination, Acceptability in terms of privacy, cleanliness, gender equity and courteous behavior and Quality in terms of clinical protocols, clinical records, infection control and outcome of care. Also provision of no fi-



nancial barrier to the services and ethical issues are also a part of this Area of Concern.

Session 3: Area of concern C- Inputs

The third session was taken up by Ms Vinny Arora. Area of concern C covers the structure part as per Donabedian model and is the only Area of concern that details about the structure component in Health facilities under NQAS. This Area of Concern covers Infrastructure and Space requirements, ensure Physical Safety in facility, Fire Safety systems, availability of skilled Human Resource, availability of Drugs and Consumables as well as equipment and instruments and, yearly assessment of staff competence.







<u>Session 4 & 5 : Quality initiatives under Child Health: MusQan & Area of Concern E - Specific Clinical Services (E19 – E20)</u>

Dr. Renu Srivastava took over this session started the presentation by explaining Quality initiatives under Child Health under MusQan. She explained the Continuum of new born care. She briefed about required structural changes for effective qualitative transformation to achieve standard benchmarks for delivering skilled evidence based newborn and pediatric ser-

vices in a humane and supportive environment. She also laid examples that how to transform a facility into a child friendly facility. Explained key strategies and also proposed actions for implementing key strategies. She discussed the roles and responsibilities of health workers at different levels of public health facilities. She covered Measurement system for MusQan, requirements under all Areas of concern under MusQan, Checklist of documents for verification of NQAS, Compliance & Scoring as well as Key Performance Indicators (KPIs) & target.

Session 6: - Exercises & discussion with moderator: Area of Concern (A, B, C & D)

After the brief discussion on the intent of Aoc A-D; exercises were supported and guided by the moderators. Participants were asked to give answers based on discussions during the sessions. Slides were shown to the participants one by one for Area of Concern D. All the groups were given scores for their responses.







DAY 3-24th August' 2022

The 3rd day training started with recap of the last day sessions by Dr. Neeraj Gautam.

Session 1 : - Area of Concern G (G1-G7)

Dr. Deepika Sharma explained about the Quality management in a facility and how a facility can improve their process and achieve the Quality improvement. She briefed to identify the problems and using Quality tools how can the Quality teams achieve the target of providing the quality services to the population near the health care facility.



Presentation made it clear how employee satis-

faction and patient satisfaction can play important role in quality improvement of a facility. Having Quality checks in the laboratory can improve the quality of diagnosis, having written and implemented procedures, records & formats, work instructions can give the wide spectrum to the employees to improve their knowledge and skills. Using the Quality tools to identify and solve the problems, conducting various audits with their analysis, preparing a strategic plan to achieve the mission and vision of the facility were also briefed during her session.

Session 2: - Area of Concern E: General Clinical Services under NQAS (E1 - E9)

Dr. Arpita Agarwal took talked about general clinical services in which she discussed standards E1 to E9. Standard to E9 covers the registration to discharge process. Standard E1 covers Registration, consultation & admission, standard E2 covers Clinical assessment & reassessment, standard covers continuity of care and referral. standard E4 covers Nursing car, standard E5 covers management of high risk & vulnerable patients, standards E6

covers implementation of STGs & generic drugs practices, standard E7 covers safe drug administration, standard E8 covers maintaining, updating, storage of records and standard E8 covers discharge of patient.

Session 3: - Area of Concern E - Specific Clinical Services under NQAS (E10-E16)

The session was delivered by Dr. J N Srivastava. He talked about the general clinical services in which he discussed standards – E 16. He elaborated on departmental Quality Standards on defined and established procedures for intensive care, Emergency Services and Disaster Management, diagnostic services, Blood Bank/Storage management and transfusion services, anaesthetic services, Operation theatre services and management and end-of-life care management.

Session 4: - Area of Concern D - Support Services Under NQAS

Dr. Chinmayee Swain took this session and started the presentation by explaining why support services are important under NQAS framework. She explained that support services are the backbone of hospital operations which are usually most neglected area in public hospitals. She laid emphasis on how support services directly and indirectly lead to poor Quality of services for example poor upkeep of facility and long down time of equipment. She added, little efforts in process improvement may give high & visible results to clinical care.

She gave the brief description of all the standards i.e. E1-E12 under support services and gave glance of comparison of standards as per level of facility. She made the participants understand the importance of the standards and means of verification were also explained in details for support services by giving examples.

Session 5: - Area of Concern F: Infection Prevention under NOAS

Dr. Neeraj Gautam explained the infection control practices. He made the session interactive by asking questions related to various infection control practices and by demonstrating various practices like hand hygiene.

He made the understanding of the standards very convenient by explaining hand hygiene practices, personal protective equipment, equipment processing, environment control and biomedical waste management. His session was pictorial

which made it more interactive and convenient for the participants to interpret.





Session 6: - Outcome Indicators under MusQan including exercise

Dr. Sushant Agrawal took this session and incorporated some exercise on quality management system and outcomes for making this session interactive and much clear. He briefed the participants on 24 KPIs under MusQan and how to track their calculation. He also briefed that under MusQan these KPIs will be verified by the team of assessors and report to be submitted to certification unit NHSRC.



Session 7: Exercise on Area of Concern D & E

The group exercises were monitored by 7 moderators where all the participants were given the sheet. Various slides were shown, and the participants were asked to identify the standards.





DAY 4- 25th August 2022

The 4th day training started with recap of the last day sessions by Dr. Arpita Agarwal.

Session 1: - Area of Concern G: Quality Management System (G8-G10)

Dr. Sushant Agrawal took this session. this session he covered stnadrad G7 to He briefed the participants on the Quality tools. Through this session he explained the risk management framework in the health care facilities, to assess, report, evaluate and manage risks as per risk management plan and talks about the clinical governance framework to improve the quality and safety of clinical care processes in the facilities.

Exercise on patient satisfaction, prescription audit, external quality assurance score for lab tests, PICK chart, pareto analysis, histogram, run chart & Failure Mode and Effects Analysis (FMEA) cleared the concepts of the participants.

Session 2: - Quality Initiatives under NQAS: LaQshya (E17-E18)

Dr. Rashmi Wadhwa took this session. focused on Maternal and Child Health Services including Intranatal care, Antenatal Care and Postnatal Care. He emphasized on established procedures care of newborn, infant and child, and procedures for abortion and family planning including Adolescent Reproductive and Sexual health Services. She covered the LaQshya program and deliberated on how to conduct the assessment under LaQshya initiative.

<u>Session 3: - Overview of National Health Programs under NQAS (E23)</u> Dr. Utsuk Dutta explained about the quality components of the NHP. He explained the programs by explaining them under communicable and non-communicable diseases and IDSP/IHIIP.

Under communicable disease she covered the following programs:

- National Tuberculosis eradication Program (NTEP)
- National AIDS Control Program
- National Vector Borne Disease Control Programme
- National Leprosy Eradication Programme

Under non-communicable disease she covered the following programs:

- National Programme for Prevention and Control of Cancer, Diabetes, Cardiovascular Disease and Stroke
- National Tobacco Control Programme
- National Mental Health Programme
- National Programme for Control of Blindness



- National Programme for Prevention and Control of Deafness
- National Programme for the Health Care of Elderly
- National Oral Health Care Programme

He gave the brief description about the IDSP/ IHIIP programs. He explained about the difference between old and new IDSP portal.

Session 5: - Ethical issues in Assessment of Health Facilities

NQAS assessment session was taken by Ms. Vinny Arora. She started her session by explaining the seven principles of assessment: - Integrity, Fair presentation, Due professional care, Confidentiality, Independence, Evidence based approach and Risk based thinking.

She also discussed about some ethical issues that has been raised by states during the external assessment. She also explained about the process of de-empanelment of assessors and how the certification process can be strengthened.

Session 6: IT initiative under NOAS platform

This session was taken up by Mr. Anand. He oriented the participants about the downloading and usage of the GUNAK app, which can be used during an assessment by the participants.





Session 7: Briefing about the field visit & Group work

Dr. Deepika Gaur briefed the participants about the field visit and gave them the instructions to be followed during the field visit. She briefed the participants about the DH selected for the field visit and divided the participants into groups. Each group had team coordinator from NHSRC team who were responsible for the coordination and guiding the teams. Dr. Deepika Gaur emphasized on the rules to be followed during the field visit & group work.

Session 8:- Role Play

In the session, assessors were briefed about the scenarios encountered during the conduct of assessments and how assessors can overcome those challenges.





Day 5-26th August


