Subject: Launch of Webinar Series for supporting the NQAS Implementation in Primary Healthcare Facilities

Dear Mission Director

Please refer to Ministry of Health and Family Welfare (MoHFW) letter no. D.O. No. Z-18015/13/2023-NHM dated 3rd February 2024 where (MoHFW) has set a target of 100% National Quality Assurance Standards (NQAS) certification of all public health facilities by December 2026. To support the NQAS certification process National Health Systems Resource Centre (NHSRC) has been increasing the pool of NQAS External and Internal assessors and also introduced new category of assessors, known as Ayushman assessors.

2. NHSRC is also supporting the states through development and dissemination of the technical resources including guidelines and the resource videos to help the AAM-SHCs and above level of healthcare facilities in attaining the NQAS certification.

3. In the country majority of Sub-Centres, PHCs and UPHCs are functioning as Ayushman Arogya Mandir. For supporting the State's efforts in implementation of National Quality Assurance Standards followed by state and national certification, a webinar series is being planned to be launched soon.

4. The online lectures will be conducted on every 2nd and 4th Thursday of the month from 2 pm onwards. Each session will be of an hour duration with 45 minutes of lecture followed by 15 minutes for Q&A. Target audience for webinar series would be state, district and block program officers responsible for primary health care, Medical Officers and Nursing staff posted at Primary Health Centres and CHOs. It is expected that within a time span of four months all topics pertaining to NQAS implementation and the certification will be covered.
