Report on Three Days Internal Assessors' cum Service Providers'

Background

Implementation of National Quality Assurance Programme in the Northeastern States has been closely monitored and supported by Regional Resource Centre for North-East States (RRCNE) in coordination with National Health System Resource Centre (NHSRC) since the launch of the programme in November 2013. A pool of assessors has been created in each State for supporting and assessing the health facilities, identification and analysis of the gaps, prioritization & action planning for closure of the gaps so that quality of the services provided in the public health facilities could be improved and taken up for National Certification

A three-day "Internal Assessors cum Service Provider Training" was held in Assam from August 28th - 30th, 2024, organized by the National Health Mission in collaboration with the Regional Resource Centre for Northeastern states. The training aimed to equip the state's nominated health professionals of the targeted health facilities & district with the skills and knowledge to implement the National Quality Assurance Program (NQAS). Participants were trained to mentor facility quality teams, following the State's action plan, and were provided with tools and techniques to help healthcare professionals to improve, sustain, and foster a culture of quality care in their facilities.

A total of 72 participants, including Medical Officers (in-charge), Microbiologist, Pathologist of District Hospitals, District Quality Consultants (DQC), and DQC incharge, Hospital Administrators, CHOs, and consultants from developmental organizations, attended the training. The program covered 17 topics, with three hands-on exercises designed to demonstrate the application of specific quality tools. The agenda of the three days' training is placed as Annexure – I.

The training was inaugurated by Dr. Neeraj Das, State Quality Nodal Officer, NHM, Assam. During the inauguration, the significance of quality in healthcare service delivery and the current status of NQAS certifications in the state were highlighted.

A post-training evaluation was conducted, which consisted of an open-book exam featuring 42 multiple-choice questions on quality improvement and the NQAS framework. Out of the 72 participants, 65 participants (around 90%) qualified the post-training evaluation and will be empanelled as internal assessors in the existing pool under NQAS. Details are available in the annexure II.

The program also incorporated a built-in training evaluation system, with participants providing feedback on a 5-point Likert scale. Based on this feedback, the overall rating for the training was 4.41 out of 5. Details are available as Annexure – III.

S1	Topic Brief			
1.	Overview of National Quality Assurance Program and assessment protocol	Dr. Ravikar Singh , Consultant at RRC-NE, took the session on the Evolution of the National Quality Assurance Standards & their implementation framework, Various initiatives/schemes under the National Quality Assurance Program, rationale, context etc. this session also covered the presentation of the measurement system for National Quality Assurance standards, identifiable elements, and essential checkpoints.		
2.	Standards for Service Provision and Patient Rights (A, B)	Dr. Munmee Das, Consultant at RRC-NE, led the session addressing the initial two Areas of Concern, namely, Service Provision and Patient Rights. A detailed discussion on Service provision as per mandate and Patient Rights, encompassing patients' entitlements to information about available services, accessibility, the assurance of being treated with dignity and confidentiality, and the removal of any physical or financial obstacles. During this session, comprehensive insights were provided regarding the range of services offered across different departments within a healthcare facility.		
3.	Standards for Inputs (C)	Dr Meena Chavan, SPM NISHTHA Jhpiego, provided an elucidation regarding Area of Concern C, along with its seven accompanying standards. This area primarily focuses on the structural aspects of healthcare facilities, adhering to the established standard guidelines outlined in the Indian Public Health Standards (IPHS) applicable to various facility levels.		
4.	Standards for support Services (D)	Dr Meena Chavan, SPM NISHTHA Jhpiego conducted this session, which emphasized the significance of Support Services within the realm of public healthcare facilities. The session encompassed an in-depth exploration of standards related to health facility maintenance, calibration, inventory management, laundry services, dietary provisions, financial management, contract management, and statutory compliance.		
5.	Standards for Clinical Services (E1 - E9)	Dr Abu Hasan Sarkar, WHO Consultant conducted a comprehensive session on the initial segment covering Standards for Clinical Services. During this session, he underscored the significance of clinical services and provided an extensive explanation of the nine Standards for Clinical Services, encompassing aspects like registration, admission, consultation, assessment, reassessment, patient care during transfer and referral, nursing care, drug administration, patient record maintenance, and the discharge process.		
6.	Standards for Infection Control (F)	Ms. Bhagya Devi Das , Quality expert, Integra ventures, led the session, which involved an extensive discourse on infection control procedures, covering topics such as hand hygiene, antisepsis, personal protective measures, equipment sterilization, environmental control, and the management of biomedical waste. In addition, a video demonstrating infection control practices was presented to the participants.		
7.	LaQshya overview	Ms. Jenita Khwairakpam, State Program Manager- Jhpiego discussed the LaQshya program and explained how the facilities can certify their labor rooms and MoTs under the LaQshya initiatives.		



8.	Standards for Specific Clinical Services (E10 - E16 & E24)	Dr Subha Kanta Behera , State Consultant-UNICEF delved into the seven standards specifically related to clinical services, designated as E10 to E16. These standards pertain to Intensive Care, Emergency, Diagnostic, Blood Bank/Storage, Anaesthetic, Surgical, and End of Life Care services. Further the std. E24 on Haemodialysis services was also discussed.
9.	Standards for Clinical Services (E17 - E23)	Ms. Jenita Khwairakpam, State Program Manager- Jhpiego, extended the focus to RMNCH+A services, with Ms. Khwairakpam delivering an in-depth discussion on the six standards tailored to Maternal, Newborn, Child, Adolescent, and Family Planning services, as well as National Health Programs. Within Maternal Services, further categorization was presented, encompassing Ante-natal, Intra-natal, and Post-natal services and National Health Program.
10.	Standards for Quality Management (G) & Internal Assessment, Root Cause Analysis, Action Planning & Prioritization	The session was taken by Dr. Ajay Kumar Arya, Consultant, QPS, RRCNE . This session includes 10 standards on Quality Management system. He discussed the importance of Quality Policy, Objective, SOP, Patient Satisfaction Survey etc. In addition, the importance of Internal assessment, Gap analysis, Prioritization, and action planning. Gap Analysis', by using "fish bone diagram" and "why-why" technique was also explained in detail with examples. The prioritization of gaps by using 'PICK' chart was explained. Later, Dr. Arya discussed the Pathway to Quality management implementation within a facility.
11.	Overview of GUNAK Application and its uses	Dr Subhakanta Behera, spoke on the overview of the application of "GUNAK" which is a quality assessment application for NQAS, LaQshya and Kayakalp. This application can be used for internal, external and peer assessment of public healthcare facilities and for identification of gaps. This application is available for both android and apple users.
12.	KPI, outcome indicators & PSS (H)	Dr Subhakanta Behera, UNICEF Consultant explained standards under the AOC H (outcome), highlighting the importance of key performance indicators and outcome indicators. He also advised the participants on the details of the patient satisfaction survey (PSS).
13	Process mapping& exercise on Process Mapping	Dr. Ajay Kumar Arya facilitated a detailed discussion on Process mapping and emphasized its importance in Quality management. He also discussed various MUDAS or waste in hospital.
14.	MusQan – An overview	Dr Hirkani Madnaik, UNICEF Consultant gave a presentation on MusQan initiative which aimed at improving the quality of child healthcare services at public health facilities in India. Dr. Madnaik focused on methods to reduce child mortality by implementing MusQan quality standards, ensuring essential services, and promoting safe, child-friendly environments across paediatric care units in hospitals and health centres.
15.	Status & road map for NQAS implementation of the state	State Quality Cell, NHM, Assam discussed the state action plan & strategy to achieve NQAS targets.
