I would like to draw reference to my earlier D.O. letter of even number dated 25<sup>th</sup> November 2024 (enclosed) whereby it was conveyed that Ayushman Bharat - Health and Wellness Centres are to be renamed as 'Ayushman Arogya Mandir' with the tagline 'Arogyam Parmam Dhanam' in the spirit of Ayushman Bharat. I am glad to inform that most of the States and UTs have undertaken the process of renaming as per the orders issued by State Government and the photos have been uploaded in the Ayushman Arogya Mandir portal.

2. In continuation of the guidelines issued vide the above referred letter, I would like to apprise that the point 'f' of the guideline has been revised as follows:
