



Report on 03-Day Internal Assessor's cum Service Provider Training on National Quality Assurance Standards (NQAS)

Introduction

The National Quality Assurance Standards (NQAS) were introduced in 2013 to enhance the Quality of Care (QoC) in public health facilities, starting with District Hospitals. In 2014, the standards expanded to include Community Health Centres (functioning as First Referral Units) and Primary Health Centres (PHCs) with beds. Subsequently, Quality Standards for Urban PHC's were developed in 2016. LaQshya guidelines for Labor Room & Maternity OT rolled out in 2017, SUMAN – A new initiative for zero preventable maternal & neonatal death was launched in October 2019, NQAS guidelines for Health & Wellness Centres rolled out in 2020 & for ensuring child friendly services in public health facilities, a new initiative called 'MusQan' for the paediatric age group within the existing NQAS framework was launched in 2021. NQAS Standards have attained International Accreditation from International Society for Quality in Healthcare (ISQua). At National level, these standards have been recognized by the Insurance Regulatory and Development Authority (IRDA) for empanelment of hospitals.

Implementation of National Quality Assurance Programme in the North-Eastern States has been actively monitored and supported by Regional Resource Centre for Northeast States (RRC-NE) in coordination with National Health System Resource Centre (NHSRC) since the launch of the programme in November 2013. A pool of assessors has been created in each state for undertaking the assessment of the health facilities, identification of gaps, analysis of the identified gaps, prioritization, action planning for closure of the gaps so that quality of the services provided in our public health facilities can be improved and they may be taken up for National certification.

A 03-day Internal Assessor cum Service Provider Training was organized by State QA Team, NHM, Tripura with the technical support of RRC-NE. The training aimed to expand the assessor pool, and RRC-NE extended support by drafting the agenda, providing study materials, and taking sessions during the training. Training programme was spread into 16 topics along with practical exercises for hands on experience on various methodologies of the assessment. Training was followed by discussion on NQAS implementation status in the State of Tripura & then training concluded with Post Training Evaluation.

Objectives and Participants

The main objectives of the training were as follow:

- 1. To impart understanding of the basic concept of Quality Assurance Standards and how to implement them in public health facilities.
- 2. To acquaint the participants with Area of Concerns, Standards, Measurable elements, Departmental Checklists and Scoring System.
- 3. To support the facilities for achieving National Quality Certification.

Training was facilitated by following Resource Persons:

Participants: A total 42 (Forty-two) Participants including District Nodal Officer, Medical Officers, Staff Nurses, Laboratory Technicians, attended the training. The Participants list along with the post training evaluation result is enclosed as Annexure – II.

Inaugural Session: Dr. Anirban Hore, State Consultant - QA, NHM, Tripura welcomed all the participants & resource persons from RRCNE, & state officials to 03-day State level Internal Assessor's cum Service Providers Training Program.

Keynote Address: In the keynote address, Joint MD NHM emphasised the importance of NQAS guidelines and its implementation in public health facilities and assured that state will extend full support to the facilities for achieving National Quality Certification.

NQAS training programs include an inbuilt training evaluation system where each participant provides feedback on a 5-point Likert scale. The overall rating of the training, based on participant feedback analysis, was 4.48 out of 5. The analysis of Training feedback is enclosed in Annexure – III.
