



INTERNAL ASSESSORS CUM SERVICE PROVIDERS TRAINING REPORT WEST BENGAL 10th to 12th July 2024

Venue: Swastya Bhawan, Kolkata

Background

A Three-day training "Internal Assessors cum Service Providers Training" was conducted in the state of West Bengal by the National Health System Resource Centre in collaboration with the Dept. of Health and Family Welfare from 10th to 12th July 2024.

The objective of the training was to train the nominated officials of the State for the implementation of the National Quality Assurance Program, by mentoring the facility quality teams as per the action plan defined by the State. This training will aid participants with the tools, techniques, and support to health professionals to enable them to implement NQAS at healthcare facilities and thereby, take ownership of improving, sustaining, and creating a culture of the quality of care.

The State had nominated 54 participants for the training including Asst. Hospital Superintendents, from different Districts. The training constituted eighteen (16) topics with seven (07) exercises for hands-on experience in the application of certain quality tools.

The training was initiated with an inaugural keynote by Dr Siddhartha Niyogi, DHS, Govt of WB, and discussed the importance of Quality in Healthcare service delivery and the current status of the NQAS certifications in the State.

A post-training evaluation was also taken during the training, post-training evaluation was an openbook exam with 42 multiple-choice questions, related to quality improvement and the NQAS framework. Out of a total of 54 participants, 50 participants (98%) cleared the post-evaluation exam and now will be empanelled as an internal assessors under the existing pool of NQAS. Also, 50 participants were joined on the last day for post-training evaluation, those who had already undergone training, but were not able to qualify.

QA training programmes have an inbuilt training evaluation system, where a feedback form is provided to each participant. Feedback from the participants is analyzed on a 5-point Likert scale. The overall rating of the training as per the analysis of the feedback from the participants was 4.66 on a 5-point Likert scale.

Key Concepts and Principles of Quality, Overview of National Quality Assurance Standards	Dr. Chinmayee Swain	This session covered key concepts of Quality, the importance of Quality in healthcare, the Evolution of the National Quality Assurance Standards & their implementation framework, various initiatives/schemes under the National Quality Assurance Program, rationale and context, etc.
Measurement system and Assessment Protocol and Checklist	Dr. Chinmayee Swain	This session covered the concepts of the Measurement system under the National Quality Assurance standards. It described the 8 Areas of Concern, Standards, Measurable Elements, Checkpoints, and Means of Verifications defined under the NQAS. It also included the scoring system with a discussion of different assessment methods and departmental checklists at various levels of healthcare facilities.
Quality standards under NQAS- AOC A (Service Provision) & B (Patient Rights)	Dr Nirmalya Roy, SNO(QA)	The session included an elaborative discussion about the first two areas of concern i.e., Service Provision (A) and Patient Rights (B). It included a brief of the availability of services in a public health facility as per the scope of the hospital and the importance of patient rights while availing the services in a hospital.
Quality standard under NQAS-AOC C (Inputs) & D (Support Services)	Dr Ananya Ghoshal Mukherjee, Dy CMOH-IV, Paschim Bardhaman	It included the inputs required by a facility for healthcare service delivery, covering the availability of adequate infrastructure, human resources, training, competencies, and the availability of essential drugs and consumables. Under support services, a detailed discussion of its 12 standards was undertaken which included the maintenance of equipment, calibration, inventory management, dietary services, laundry services, security services, community participation, financial management, contract management, legal & statutory requirements, etc.
Quality standard under NQAS-AOC E (Clinical Services)	Dr Urbi Das,State Consultant	The session briefed participants regarding the general & specific clinical service standards from E1 to E24. It covered the process from registration to discharge and end of life under these standards, including the referral service. The session also discussed the importance of quality of clinical services with a focus on standards of special Clinical services such as nursing care, drug administration, patient record maintenance, and discharge process, etc.
Quality standard	Dr. Arijit	The session covered a detailed discussion about infection

It included the discussion on the latest biomedical rules and the amendments with a focus on the implementation and assessment of infection control practices at public healthcare facilities. Additionally, the key concepts of an Infection Control Audit were briefed to the participants.		
Quality standard under NQAS-AOC G (Quality Management)	Dr. Chinmayee Swain	The session covered the steps in the formation of a quality team in the facility and, the importance of recording minutes of meetings (MOM) after every meeting. It also explained implementing IQAS and EQAS at the facility, conducting quarterly internal assessments of all the departments, identifying gaps, and mitigation plans to close them. The formation of the Quality policy and the objectives of the facility were also discussed.		
PSS with Exercises	Smt. Pushpita Ghanta, State Consultant	The session covered all the steps related to the Patient Satisfaction Survey including the calculation of PSS score. Also, she discussed about the CAPA (Corrective Action & Preventive Action) for the lowest attributing score.		
Quality standard under NQAS-AOC -H (Outcome)	Smt. Pushpita Ghanta, State Consultant	The session included a discussion on the KPIs and Outcome indicators under the NQAS along with their calculation, reporting, and analysis at the facility, district & state levels.		
PDCA / 5S with Exercise	Dr Nirmalya Roy, SNO(QA)	This session taught the Plan, Do, Check, Act cycle for improvement and sustenance of progress achieved after the incorporation of intervention/change in the process for achievement of set objectives. The concept was well-illustrated with examples. It also illustrated that by implementing 5S, we can minimize waste, streamline procedures, and ensure a sustainable foundation for quality in the facility, with an exercise.		
Process Mapping with Exercise	Dr Nirmalya Roy, SNO(QA)	This session helped participants gain a clear understanding of how a process functions, identify areas for improvement, and ensure consistent quality outputs, with an exercise by the participants.		
Prescription Audit with exercise	Dr Nirmalya Roy, SNO(QA)	It covered how to conduct a prescription audit at the facility with the help of an example. The exercise was done by the participants on prescription audit.		
Internal Assessment and Gap Analysis with Exercise	Dr Urbi Das, State Consultant	This session covered the process for internal assessment and then identifying the gaps with an exercise by the participants.
